Covid – 19 Required Guidelines
Revised April 28, 2020
State Approved Opening date of May 1, 2020

All Campers = Transit, Overnigheters, Weekenders, Cabins and Seasonal are required to sign below that you have read, understand and agree to abide by these guidelines:

Shady Brook Campground & Boat Rental, LLC will be open for business starting MAY 1, 2020 and welcoming you back. As always, we have the safety and well-being of our visitors and staff in mind. We continue to monitor the situation with COVID-19 and will keep you updated as needed when new information becomes available.

While we are excited to have you return to the park, we do ask that if you are sick and/or experiencing symptoms consistent with the COVID-19 infection that you please refrain from coming to Shady Brook Campground & Boat Rental, LLC.

We are taking the recommended precautions from ARVC, Centers for Disease Control and Pa. Dept. Of Health and all public spaces will be closed. This includes all bathrooms, showers, office, store, playground, play field, pond area, and pavilion are to remain closed and will not be open for any reason. It will be important for you to make all of your family and children aware of these policies.

You will be allowed to come to your sites and enjoy your time with your family in a great outdoor environment. Should, however, there be violations of these policies, they will result in termination of your ability to be at the park until the threat of COVID-19 has passed and life resumes as we knew it. If we have rampant misuse across the park, we will only be forced to move the opening date, and that would ruin it for everyone.

We don't want to have to police things, we just want to allow everyone the opportunity to get away from the craziness, enjoy nature in an open environment, and continue to be socially-conscience and abiding citizens who are all doing our part to minimize the impact of this virus

Campers should know that many normal daily operations not considered life-sustaining will not resume at this time. However, we are permitted to open during phase one, utilizing limited staffing and limited consumer interaction. Our campground owners, staff and volunteers will do due diligence to limit and stop congregation of guests. Upon opening, campgrounds must have policies in place to mitigate the spread of COVID-19. This list is our campground plan and will need to be fluid and will change as the region our campground is in changes during each stage of the re-opening process.

Shady Brook Campground uses a (FREE) campground APP please visit either the Apple Store or Google Play and down load the CampersAPP.....Search campground Shady Brook Campground, Beavertown, PA. Password is: Shadybrook. Any purchases made thru CampersAPP must be paid with a Credit card. IF you have advance funds credited to your account you may TEXT (570) 837-9773 with your supply/snack order and the funds will be deducted from your account. ALL ITEMS purchased will be delivered to your campsite. This APP allows you to order supplies, order firewood, and check activities.

• **AS a (Grand) Parent it is your responsibility to ensure your children Know & understand these guidelines.**

- No grouping at your cabin or campsite. All people gathering at your cabin or seasonal campsite must be on your registration form. No other persons may join you for a community campfire. NO Campsite to campsite visiting. No other family may be on your campsite or in your trailer at any time during your stay. NO VISITORS will be permitted to come to the campground.
- Cabins; there will be no back-to-back rentals. We will be using CDC/EPA approved disinfectant to clean everything as we always do, but we plan to leave a 24-hour turnaround time following cleaning to be extra cautious. All people who are renting cabins are also expected to bring their own dish soap and personal soap and other personal items with them. NO linens, pillows, towels, washcloths, etc. are provided. NO Dishes, utensils, cooking appliances etc. will be provided. None of the cabins have restrooms or showers in them, you will need to use the campground public restrooms & showers.
- All group activities where people congregate in one place are cancelled.
- Campers are encouraged to camp close to home.
- You are Discouraged from purchasing groceries or other items locally. Please shop at home and bring your supplies with you. The campground store does have limited food items, and camping & RV supplies please use CampersAPP to shop the campground store. The more groceries YOU purchase either from Campground Store or bring with you, the more CDC guidelines we are following.
- All Campers are Encouraged to use online ordering from campground using CampersAPP all items will be delivered.
- All Campers are required all to wear masks if entering any of the buildings, and entry will be denied to individuals not wearing masks
- All Campers / individuals must wear a mask when off their campsites or when with-in close proximity (6Ft) to other individuals.
- Campers are permitted to walk on roadways or trails on campground property BUT must maintain social distancing of a minimum of 6 feet, and must wear face mask when in the company of others.
- The following areas are closed and OFF limits; playgrounds, playsets, pond area, pavilion, store, office, ball pits/courts, hot tubs, water parks and water playgrounds. Remove any balls for recreation such as basketball, volleyball etc. All organized and group sports are to be closed.
- Ensure guests practice social distancing by spreading out, and removing if necessary, chairs, lounges, tables etc.
- Children are permitted to ride their bikes on your campsite or the road immediately in front of your campsite. PLEASE inform the children that grouping is prohibited, also advise them that the playground, pavilion, and store / office is closed.

SWIMMING POOL:

- MAXIMUM number of persons inside pool enclosure is 25 people TOTAL. After 25 capacity is reached then it shall be a revolving door. **(Example: 1 Person leaves enclosure 1 Person may enter enclosure)**
- IT does not matter if you are swimming or sitting MAXIMUM 25 People. The number of guests in the swimming area must ensure the 6-foot rule can be and is followed.
- When Sitting or Sunning you must ensure the 6 Foot rule is followed, Masks Must be WORN when not in the water.
- **IF any one** of the following conditions are met, you must limit your pool time to a Maximum time limit of 2 Hours, 1) Holiday 2) Hot day 3) High campground use 4) the Pool enclosure MAX 25 persons has been reached.
- **NOTE:** if leaving because of 2 hour limit after departing and allowing 1 hour to pass you may return to the pool and return swimming waiting your turn and following the above guidelines.

- WHEN you are departing from the pool enclosure you must first Sanitize (spray down with disinfectant) all areas you were seated or handled.
- WHEN arriving into the pool enclosure it is your responsibility to Spray and disinfect any chairs, tables or lounges you wish to use.

According to the CDC, there is no evidence that COVID-19 can be spread to humans through the water. Proper operation, maintenance, and disinfection (with chlorine or bromine) of pools should kill COVID-19.

Swimming and other water-related activities are excellent ways to get the physical activity needed for a healthy life. If you are not sick or experiencing symptoms of COVID-19, it is safe to use swimming pools as long as steps are taken to reduce the spread of COVID-19.

RESTROOMS / SHOWERS

- Restrooms & Showers Building will only be unlocked under the following schedule
- They will be Unlocked Friday after 11 AM , Saturday ALL Day and Sunday Till 6 & Holidays
- Bathroom will be closed and unavailable during all Cleaning times & use is prohibited.
Cleaning Times: 9 AM, 1PM, 5PM, 9PM Closed for 1 Hour
- Bathrooms will be closed and Locked from Sunday 6 PM thru all week till Friday at 11 AM

Availability:

- They may only be used by Transit / Overnight campers, And Cabin rentals.
- Mask must be worn when possible.
- Cans of Spray Lysol will be available to use as needed.

- **ALL SEASONAL CAMPERS, CAMPSITES & their families MUST USE the bathroom & shower facilities located within their camping unit. ALL BATH HOUSE & SHOWERS are OFF limits To Seasonal Campers.**
